BE IT REMEMBERED that on the 5th day of September, A.D. 2018 the Commissioner Court of Howard County met in Regular session at 3:30 PM with KATHYRN G. WISEMAN, County Judge as the Presiding Officer. The following members were present: OSCAR GARCIA, Commissioner Precinct No. 1, CRAIG BAILEY, Commissioner Precinct No. 2, JIMMIE LONG, Commissioner Precinct No. 3 and JOHN H. CLINE, Commissioner Precinct No. 4.

Peggy Skiles from Keep Big Spring Beautiful spoke with the Court about the possibility of planting desert plants on the East side of the County Library. The project is to be funded by Keep Big Spring Beautiful, but requests that the County provide water. No action taken at this time.
