BE IT REMEMBERED that on the 10th day of January, A.D. 2018 the Commissioner Court of Howard County met in Regular session at 3:30 PM with KATHYRN G. WISEMAN, County Judge as the Presiding Officer. The following members were present: OSCAR GARCIA, Commissioner Precinct No. 1, CRAIG BAILEY, Commissioner Precinct No. 2, JIMMIE LONG, Commissioner Precinct No. 3 and JOHN H. CLINE, Commissioner Precinct No. 4.

Commissioner Craig Bailey introduced Vince Vialle, Specialized Public Finance, Inc. Mr. Vialle spoke about Bond requirements in regards to financing the new radio system for the Sheriff's Department. He went through the booklet that he handed out and discussed how the process works. This presentation was for information purposes and no action was needed.

Carlos "Charlie" Leal, citizen who registered to speak, talked about how the County roads are being torn up by the heavy oilfield traffic. He stated he believes there are possible ways to raise money to fix these roads. No action needed.
