ITEM 11. Safety Meeting Monthly Report - Lynn Jeffries No report was submitted.

ITEM 12. Tax Assessor/Collector Monthly Report – Karen Lane, Tax A/C May 2020 Taxes Collected, Fees Collected, Vehicle Fees, and Texas Parks and Wildlife Fees were reported by Karen Lane, County TAC. See attached.

ITEM 13. Emergency Management Report - Shelly Butts

Judge called on Shelly Butts, Emergency Management Coordinator to report on the County COVID-19 cases. She said, as you know businesses are opened to a 50% occupancy. Governor Abbott opened more businesses in Texas on June 3, 2020, and June 12, 2020, county local restaurants and other businesses can open to 75%, because we do not have 10 or more active cases, there are three active cases in our county. Texas Department of Criminal Justice reported six confirmed cases in the Ferguson Unit, but those are not a part of our county count. No confirmed cases were reported from COVID-19 testing at nursing homes, Butts said. Judge Leago said it appears our county can recoup some expenses from the CARE Grant, \$104,000 received recently. Butts said some salaries, administrative leave, glass dividers in courtrooms, county offices and other expenses should be eligible for reimbursement. Judge Leago said the county has until the end of December 2020 to spend the monies or otherwise return it.

ITEM 14. County Extension Agent Monthly Report – Chadd Caperton No report was submitted.

ITEM 15. Veterans Affairs – Danny Singletary

Judge Leago called on Danny Singletary, Veterans Service Officer for a report. Singletary said his office has slowed down tremendously due to the virus, but he made three trips with Veterans to Bryan College Station healthcare facilities and is assisting one Veteran with his pension application.

Judge Leago said this is a service being offered to Madison County Jail, Gamma Healthcare Radiology will come to the jail and provide X-ray services as needed. The fee is less than \$100 and it is a plus for the county, so Judge made a motion to accept this agreement, Commissioner Pohorelsky moved for its approval and Commissioner Wiseman seconded the motion; Judge Leago called for a vote.

This is an agreement the county has with St. Joseph EMS, and it is time for renewal, Judge said. After contacting the hospital, Judge told EMS Services we did not want to see anything changed, we prefer to keep it the same and they agreed. The COVID-19 has delayed the hospital in getting agreements prepared, so they have given our county a one-year extension to its current contract. It will give the newly hired EMS Director time to review and prepare a new contract, Judge said.
