

BE IT REMEMBERED that on the 2nd day of January, A.D. 2019 the Commissioner Court of Howard County met in Special session at 10:00 AM with **KATHYRN G. WISEMAN**, County Judge as the Presiding Officer. The following members were present: **CRAIG BAILEY**, Commissioner Precinct No. 2 and **JOHN H. CLINE**, Commissioner Precinct No. 4. **OSCAR GARCIA**, Commissioner Precinct No. 1 and **JIMMIE LONG**, Commissioner Precinct No. 3 were absent.

This Special meeting was called for the purpose of swearing in Officials.

A motion was made by Commissioner Bailey and seconded by Commissioner Cline to accept the Election results as reviewed by Jodi Duck, Elections Administrator. Howard County had 7,433 total votes which was a 44% voter turnout. That was an almost 9% increase over the 2014 Elections. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

The following officials were sworn in at this ceremony: Kathryn Wiseman County Judge; Craig Bailey, County Commissioner, Pct. 2; John Cline, County Commissioner, Pct. 4; Brent Zitterkopf, County Clerk; Robert Fitzgibbons, JP 1-2, Connie Shaw, JP 2; and Angela Griffin (Appointed), JP 1-1.

A motion was made by Commissioner Bailey and seconded by Commissioner Cline to adjourn at 10:18 AM. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.
