WISEMAN**, County Judge as the Presiding Officer. The following members were present: **EDDILISA RAY**, Commissioner Precinct No. 1, **CRAIG BAILEY**, Commissioner Precinct No. 2, and **JOHN H. CLINE**, Commissioner Precinct No. 4. **JIMMIE LONG**, Commissioner Precinct No. 3 was absent.

The Budget Workshop was called to order @ 1:33 PM.

The Court heard from Sheriff Stan Parker about the possibility of requesting a variance from the State for more beds which would require at least 2 more positions. No action taken at this time.

Itzel Gomez, Emergency Management Coordinator, presented an update of the Howard County 5 year Emergency Plan.

A motion was made by Judge Wiseman and seconded by Commissioner Ray to designate Sheriff Parker as the Public Information Officer for Howard County. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Bailey and seconded by Commissioner Ray to approve the 5 year Emergency Management Plan with changes discussed during presentation and discussion presented by Itzel Gomez, Emergency Management Cooridinator. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Cline and seconded by Commissioner Bailey to approve the change in travel policy as presented by Jackie Olson, County Auditor. A vote was taken and the members of the Court unanimously voted "AYES" with Commissioner Ray abstaining from the vote. Motion carried.

Jackie Olson, County Auditor, gave reports on various funds for information only. No action required.

A motion was made by Commissioner Ray and seconded by Commissioner Bailey to rescind the previous motion and vote concerning the travel policy. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Ray and seconded by Commissioner Bailey. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Ray and seconded by Commissioner Bailey to approve the naming of a road in Precinct 3 running West of Wasson Road as Sam's Road on this the 2<sup>nd</sup> Reading as presented by Brian Klinksiek, County Road Administrator. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

Brian Klinksiek, County Road Administrator, gave an update on the TxDOT CTIF Grant List of Transportation Projects as a matter of information. No action needed.

Brian Klinksiek, County Road Administrator, also gave Roadway Maintenance Updates with no action necessary.

Judge Wiseman reminded the Court there is a Special Meeting scheduled for Friday, 07/30/2021 @ 10:00 AM.

Judge Wiseman informed the Court that Itzel Gomez, Emergency Management Coordinator sent out a letter to the Public concerning COVID vaccines and where they can be obtained. No action necessary.
