CLINE**, Commissioner Precinct No. 4.

The Workshop was called to order @ 2:05 PM

Jackie Olson, County Auditor, introduced Robb Pridemore of USI Insurance who explained the benefits of changing him from being our Insurance Agent to the Broker of Record which should save the County approximately \$12362 based off of the current program.

A motion was made by Commissioner Long and seconded by Commissioner Ray to name Robb Pridemore of USI as our Broker of Record as presented by Robb Pridemore. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

Commissioner Long introduced Kenneth Burns of Burns Architecture, LLC that discussed the plans for the expansion of the Law Enforcement Center discussing the needs and the plans he has come up with to fulfill those needs. No action taken on this date.

Commissioner Bailey discussed a Contract with MP2 Energy for Electricity proposed at .0453 for 3 years. Action will be taken in the Regular meeting.

The requests are as follows: Library for Children's books from Ingram @ \$2550; IT for 15 Dell Optiplex 7000 computers from Dell @ \$21496.20; IT for computer replacements & supplies from Amazon @ \$2823.74 as presented by Jackie Olson, County Auditor. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

There were no Budget Amendments on this date.

A motion was made by Commissioner Long and seconded by Commissioner Ray to approve an Order for Early Payment of Invoices as presented by Jackie Olson, County Auditor. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Long and seconded by Commissioner Cline to approve the bid from Rose of Sharon Shutters for \$91710 for the Courthouse and \$6608 for the District Court Building as presented by Commissioner Long. This is to be paid from ARPA Funds. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

No bids were received for the 4th Floor Incarceration Facility Removal so the job will be re-bid and presented at a later date as presented by Commissioner Long.

A motion was made by Commissioner Bailey and seconded by Commissioner Ray to approve the Contract for Electricity with MP2 @ .0453 for 3 years as presented by Commissioner Bailey. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

Jackie Olson, County Auditor, requested permission to pay for Newly Elected Officials Training. Commissioners approved and no action was necessary.

Tiffany Sayles, Tax Assessor-Collector, stated that after the school bond elections did not pass during the Election she will have to send out new statements and give some refunds to those who have already paid there taxes due to the fact that the school districts will have to reset there rates. This was a point of information and no action was needed.

A motion was made by Commissioner Bailey and seconded by Commissioner Long to approve an Order Prohibiting Outdoor Burning for a period of 90 days as presented by Commissioner Bailey. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Bailey and seconded by Commissioner Ray to approve an Order Prohibiting Sale or Use of Certain Fireworks in Unincorporated Areas of Howard County, Texas as presented by Commissioner Bailey. Brian Klinksiek, County Road Administrator, gave roadway updates and discussion concerning grants. No action needed.

A motion was made by Commissioner Long and seconded by Commissioner Ray to approve a bid RFB 2023001 Wildfire Rd Inverted Bid from Herring Services in the amount of \$106,280.97 as presented by Brian Klinksiek, County Road Administrator. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Bailey and seconded by Commissioner Ray to approve the naming of Kent Morgan Road off of Larry Tubb Road in Pct 2 on the 2nd reading as presented by Brian Klinksiek, County Road Administrator. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Cline and seconded by Commissioner Bailey to approve the County Clerk's Monthly Report for October 2022 as presented by Brent Zitterkopf, County Clerk. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Long and seconded by Commissioner Bailey to approve a Deed Preservation Project with Kofile in the amount of \$156,134.40 as presented by Brent Zitterkopf, County Clerk. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.
