BE IT REMEMBERED that on the 12th day of December, A.D. 2022 the Commissioner Court of Howard County met in Regular session at 3:30 PM with **KATHRYN G. WISEMAN**, County Judge as the Presiding Officer. The following members were present: **EDDILISA RAY**, Commissioner Precinct No. 1, **CRAIG BAILEY**, Commissioner Precinct No. 2, **JIMMIE LONG**, Commissioner Precinct No. 3 and JOHN H. CLINE, Commissioner Precinct No. 4.

Court was called to order @ 3:31 PM.

A motion was made by Commissioner Ray and seconded by Commissioner Bailey to table any action on the Process of Appointing Trustee – Phillip Reid Water Control & Improvement District No. 1 as presented by Judge Wiseman. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Ray and seconded by Commissioner Long to approve the Monthly Reports for November 2022 for Angela Griffin, JP1 -1, Mike Averette, JP 1-2 and Kelly Seales, JP 2 as presented by Judge Wiseman. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

The Court moved into Executive / Closed session @ 3:34 PM. They held the Executive / Closed sessions requested by Sheriff Stan Parker for Personnel Matters, Commissioner Bailey for Contract Negotiations and Commissioner Long for Contract Negotiations at this time, one after the other.

Court reconvened @ 4:16 PM.

A motion was made by Commissioner Bailey and seconded by Commissioner Long to approve the Member Purchasing Partnership with Dell – Proposal with allows County Employees to purchase Dell products at a discount as presented by Odis Franklin, IT Director. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

County employees will be able to able to have a Microsoft Office personal account as long as they are employed by the County. It will stop when no longer employed by the County. This was presented by Odis Franklin, IT Director and no action was necessary.

A motion was made by Commissioner Bailey and seconded by Commissioner Ray to approve the required Cyber Training Program from KnowBe4 as presented by Odis Franklin, IT Director. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Ray and seconded by Commissioner Cline to approve the Personnel Considerations as presented by Sharon Adams, Treasurer. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.
