The Workshop was called to order @ 9:00 A.M.

The Court brought in John Cline and Steve Boatenhamer for interviews as Nominees to the 911 Board of Directors for the County. The Commissioners discussed with these gentlemen what they expect and need from the County Representatives. They also allowed them to ask questions of the Court.

The Court also discussed 911 Board updates received.

Judge Johnson also asked the Commissioners about attending the V.G. Young Institute for County Commissioners Courts February 20-22, 2024. Commissioners Ray and Wagner plan to attend the Conference.

Court recessed @ 10:12 AM.

Court reconvened @ 10:15 AM in Regular Session.

The Court moved into Executive / Closed Session for a request to modify the terms/conditions for Recover Energy 381 Agreement. Also for request to modify the terms/conditions for an unnamed 381 Agreement as requested by Mark Willis, EDC.

Court reconvened in Regular Session @ 10:31 AM.

A motion was made by Commissioner Long and seconded by Commissioner Ray to approve an Extension until June 30, 2024 on the Crusoe 381 Agreement as decided in the Executive / Closed Session. No paperwork presented to the Clerk. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Berry and seconded by Commissioner Wagner to extend the Recover Howard LLC 381 Agreement for 1 year as decided in the Executive / Closed Session. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Long and seconded by Commissioner Berry to appoint John Cline as the Commissioner's Court Nominee to the 911 Board of Directors. A vote was taken and the members of the Court unanimously voted 4 "AYES" and 1 "NAY" from Commissioner Ray. Motion carried.

A motion was made by Commissioner Long and seconded by Commissioner Berry to approve the Subdivision and Manufactured Home Rental Community Regulations as presented by Judge Johnson. No paperwork provided to the Court at this time. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

The Court gave Lindsay Wilkerson, County Attorney, permission to move forward with process of selling the County owned property at 301 Spring Creek Road. No action needed.

A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Wagner and seconded by Commissioner Ray to approve the Invoices as presented by Jackie Olson, County Auditor. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

Commissioner Long reported there will be a vendor change on the Memorial metal railing that has been previously approved. The bid from the new vendor is \$12,000. Which is a large savings from the previous one who backed out on doing the job.

A motion was made by Commissioner Long and seconded by Commissioner Berry to approve the Purchase Requests as presented by Jackie Olson, County Auditor. The requests are as follows: Jail for open PO for medical supplies from Walmart @ \$1000; Sheriff for 2 air conditioning units from SKC @ \$54,990; Maintenance for LED lights with emergency battery at the District Court building from Cain Electric @ \$1300; County Attorney for criminal case files from unnamed vendor @ \$2484; District Attorney for chairs for office from Uline @ \$1110; Jail for restraint chair from ICS @ \$4070.59; Elections for ESRI Subscription Renewal from ESRI @ \$1096.16; Elections for 8 rolling workstations from Amazon @ \$775.92; Elections for 12 stackable chairs from Amazon @ \$1179.99; Elections for 2 room dividers from Amazon @ \$3919.98; Elections for 30 mobile rolling desks from Amazon @ \$1799.70; Elections for 9 door storage locker from Amazon @ \$149.99; Elections for 6 room dividers from Amazon @ \$5579.84; Elections for 6 dividers from Amazon @ \$8279.94; Jail for 6 portable radios from L3Harris @ \$1740. Brian Klinksiek, County Road Administrator, gave Roadway update on cattleguard installation in Precinct 2 as well as an update on Stallings Road repairs.

A motion was made by Commissioner Ray and seconded by Commissioner Berry to give permission to put the GIS County Road map online for Public Use as presented by Brian Klinksiek, County Road Administrator. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Long and seconded by Commissioner Wagner to accept the County Clerk's Monthly Report for November 2023 as presented by Brent Zitterkopf, County Clerk. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

Sandra Verdin, Head Librarian, reported that the 2 grants previously applied for were received. On from TWC to attend the annual conference and one from the Texas State Library to set up a Family Place Library for \$7183 as well as for staff to attend training.
