BE IT REMEMBERED that on the 10th day of April, A.D. 2023 the Commissioner Court of Howard County met in Workshop @ 1:30 PM and in Regular Session at 3:30 PM with RANDY JOHNSON, County Judge as the Presiding Officer. The following members were present: EDDILISA RAY, Commissioner Precinct No. 1 (arrived @ 1:48 PM), CASH BERRY, Commissioner Precinct No. 2, JIMMIE LONG, Commissioner Precinct No. 3 and DOUG WAGNER, Commissioner Precinct No. 4.

Workshop was called to order @ 1:31 PM.

Angela Griffin, JP1-1, came in for Kandi Campbell, JP2, concerning the JP2 budget update concerning a John Doe burial for a body that is currently with South Plains Pathology. There was no action taken on this date.

Mark Willis with the Economic Development Corporation spoke requesting an Economic Development Incentive for an unnamed company that is possibly going to open a location in Big Spring. Action will be taken during the Regular Session.

Judge Johnson presented to the Court that the County is required to form a Salary Grievance Committee that is to be made up of the following Elected Officials: Sheriff, County Tax Assessor-Collector, County Treasurer, County Clerk, District Clerk and County Attorney. In addition, it is to include 3 community members to be made up of those that have served on a Grand Jury in the last Calendar Year, as per Local Government Code Title 5: Chapter 152. Section .014 and .015. Those community members names were drawn by random draw in the order they are to be called if and when the Committee needs to be activated. Action will be taken in the Regular Meeting.

The Court then moved to the Courthouse Annex Building to tour the facility and discuss the maintenance and other needs at that building. No action taken concerning the tour.

The meeting reconvened in Regular Session @ 3:33 PM.

A motion was made by Commissioner Long and seconded by Commissioner Ray not to move forward with a 381 Agreement with 3-D Development, LLC as requested by Mark Willis of the Economic Development Corporation. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

Judge Johnson read the Sexual Assault Awareness Month Proclamation he signed to recognize Sexual Assault Awareness Month in Big Spring, Howard County, Texas as we work together to eliminate sexual assault from our community. No action needed.

A motion was made by Judge Johnson and seconded by Commissioner Wagner to approve the Salary Grievance Committee as presented by Judge Johnson. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Long and seconded by Commissioner Wagner to move forward with the process of obtaining the Rural Regional Public Defender Sustainability Grant and then review it if received before accepting as presented by Judge Johnson. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Long and seconded by Commissioner Ray to move forward with the Agreement for Temporary Contract Services with Walker Planning Group, LLC and giving Judge Johnson permission to sign the contract once it has been signed by Cameron Walker. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Long and seconded by Commissioner Ray to accept the March 2023 Monthly Reports for Angela Griffin, JP1-1, Mike Averette, JP1-2, Kandi Campbell, JP2-1 and November 2022 thru March 2023 for the Texas Agrilife Extension Service as presented by Judge Johnson. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Long and seconded by Commissioner Ray to accept the Treasurer's Monthly Payroll Report for March 2023 as presented by Sharon Adams, County Treasurer. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Ray and seconded by Commissioner Berry to approve the Personnel Considerations as presented by Sharon Adams, County Treasurer. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Long and seconded by Commissioner Wagner to accept the County Auditor's Monthly Report for February 2023 as presented by Jackie Olson, County Auditor. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Berry and seconded by Commissioner Wagner to approve the Invoices as presented by Jackie Olson, County Auditor. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Long and seconded by Commissioner Ray to approve the Budget Amendments as presented by Jackie Olson, County Auditor. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Long and seconded by Commissioner Wagner to approve an Easement Agreement with Big Spring Sands LLC adding to the agreement that both parties must agree on any renewal and then allowing the County Judge to sign the contract once the that amendment has been made and the contract is signed by Big Spring Sands as presented by Commissioner Long in the absence of Joshua Hamby, County Attorney. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

Chad Coburn, County Extension Agent gave an update and overview of the Ag-Program. No action needed.

A motion was made by Commissioner Long and seconded by Commissioner Ray to accept the County Clerk's Monthly Report for March 2023 as presented by Brent Zitterkopf, County Clerk. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

Brian Klinksiek, County Road Administrator, gave roadway maintenance updates in Precincts 1 & 3 as well as letting Commissioners know the best way for potholes on County Roads to be reported. No action needed.

A motion was made by Commissioner Ray and seconded by Commissioner Berry to give permission to go out for bid on RFB 2023003 OCC and RFB 2023011 CR 40 (no paperwork provided to Clerk) to complete the TxDOT Grant as requested by Brian Klinksiek, County Road

Administrator. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Berry and seconded by Commissioner Wagner to accept the low bids on RFQ2023005M from Phillips Fabrication @ \$227,880 and RFQ 2023006M to Landers Septic & Concrete @ \$19,620 as presented by Brian Klinksiek, County Road Administrator. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

The Court reconvened in Regular Session @ 5:17 PM with no action being taken from the Executive / Closed Session.
