The Workshop was called to order at 1:01 PM.

Judge Johnson opened the meeting with discussion concerning the Commissioner's Court Procedures & Organization. No action taken during Workshop. The Court also discussed topics to be presented during the Howard County Summit.

The meeting was recessed @ 2:16 PM. Commissioners Ray and Berry went to tour the Road & Bridge Department during the recess.

The meeting reconvened @ 3:33 PM.

A motion was made by Johnson and seconded by Commissioner Long to adopt the Commissioner's Court Procedures and Organization as discussed in the Workshop. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

Judge Johnson recapped what was discussed in the Workshop prior to the Regular Meeting. He also made the Public aware of Permian Basin Juvenile Justice Center Proposal and spoke of the shortage of beds for Juvenile Detention. He said that Howard County plans to participate in getting that facility to the Permian Basin. No action needed at this time.

A motion was made by Commissioner Ray and seconded by Commissioner Wagner to approve the Personnel Considerations as presented by Sharon Adams, County Treasurer. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Berry and seconded by Commissioner Ray to accept the Treasurer's Monthly report for January 2023 as presented by Sharon Adams, County Treasurer. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Long and seconded by Commissioner Wagner to accept the Treasurer's Monthly Payroll Report for February 2023 as presented by Sharon Adams, County Treasurer. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Ray and seconded by Commissioner Berry to approve the Invoices as presented by Jackie Olson, County Auditor. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Long and seconded by Commissioner Berry to table a request for 5 copiers for various offices in order to get more information on whether to purchase or lease copiers. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Long and seconded by Commissioner Berry to approve the Purchase Requests as presented by Jackie Olson, County Auditor, and Commissioner Long. The requests are as follows: Sheriff for Investigations training class from Credit Card @ \$1200; Sheriff for training for Natalie Oliver from Tyler Connect @ \$1099; Sheriff for CAC Interview System from unnamed vendor @ \$5162.37; Sheriff for 2 radars and 1 remote from Stalker Radar @ \$3175; Sheriff for vehicle repair from Crossroads Collision Center @ \$1952.50; Sheriff for 1 Tahoe from Caldwell Country @ \$52000; Commissioner Long for signage for the Military Memorial at the Courthouse from ebay @ \$6186.22; Commissioner Long for material and labor to replace handrailing around perimeter of Courthouse cellars and East side arched staircase from Wilson's Welding @ \$49360 (also giving Auditor permission to pay 20% in advance). A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

There were no Budget Amendments on this date.

A motion was made by Judge Johnson and seconded by Commissioner Wagner to approve the renewal of the Official Bond and Oath of Judge Angela Griffin as presented by Judge Griffin. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Berry and seconded by Commissioner Wagner giving permission for the Librarian to seek grants, Read Across Texas 2023 Library Grant and Arts Respond Performance Support Grant from the Texas Commission on the Arts as requested by Sandra Verdin, Head Librarian. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

Sandra Verdin, Librarian, introduced the new Children's Librarian, Julianna Sanchez, to the Court.

A motion was made by Commissioner Long and seconded by Commissioner Wagner to approve a lodging reimbursement request for Julianna Sanchez @ \$279 and Sandra Verdin @

\$267 for training to be held in April as requested by Sandra Verdin, Librarian. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Long and seconded by Commissioner Ray to approve Sump Pump Replacement for the Library and Courthouse from James Lane Mechanical @ \$87778.87 as presented by Commissioner Long. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

Brian Klinksiek, County Road Administrator, gave the Bridge Inspection Report for 6 bridges in Howard County. No action needed.

A motion was made by Commissioner Berry and seconded by Commissioner Ray to approve RFQ2023003M (Flex Base Recap) approving the only bid from Tubb Quarry and upping the original quantity for a total of \$136,000 as presented by Brian Klinksiek, County Road Administrator. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Ray and seconded by Commissioner Wagner to set the speed limit on Leatherwood Road between US 87 & CR 21 at 55 MPH as presented by Brian Klinksiek, County Road Administrator. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Judge Johnson and seconded by Commissioner Wagner to give permission to go on bid for cattle guards and seals as requested by Brian Klinksiek, County Road Administrator. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Judge Johnson and seconded by Commissioner Berry to allow taking some Road & Bridge employees to the Reeves County Employee Expo & Truck Rodeo training as presented by Brian Klinksiek, County Road Administrator. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

Sheriff Parker cancelled his request for an Executive / Closed session.

A motion was made by Commissioner Long and seconded by Commissioner Berry to approve hiring an employee and be double staffed for approximately 6 weeks to train for an employee retiring in May as presented by Sheriff Parker. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

Commissioner Long reported that the removal process in the old jail started on this day. He also reported that the air conditioning on the roof installation will begin on the roof next week and hopefully also completed next week.
