A motion was made by Commissioner Ray and seconded by Commissioner Wagner to accept the County Clerk's Monthly Report for February 2023 as presented by Brent Zitterkopf, County Clerk. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

The Court discussed future agenda items as well as an update on the demolition being done in the old jail. Judge Johnson reported there is a possibility of a Public Defender's Office in conjunction with other Counties. Commissioner Long recognized Commissioner Ray for the Grant Writing she does for the County including a grant the Library recently received in the amount of \$100,000.
