The Workshop was called to order at 2:09 PM.

During the Workshop the Commissioners began with Commissioner Long reviewing and sharing updates of ongoing projects with discussion among the new members of the Court. The Court then toured parts of the Courthouse to get familiar with the facility and the projects that are ongoing.

The Court recessed @ 3:18 PM.

Court reconvened in Regular Session @ 3:32 PM.

A motion was made by Commissioner Ray and seconded by Commissioner Wagner to leave the Pro-Tem Judge position open and the Commissioner that is present with the most seniority will lead Commissioner's Court the meeting in the event that Judge Johnson is absent as discussed by the Court. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Long and seconded by Commissioner Wagner to appoint Phillip Reid as Trustee of the Water Board District #1 in the process of dissolving the Board as presented by Phillip Reid, current head of the Water District Board. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

Phillips Revocable Living Trust as presented by Jackie Olson, County Auditor. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Long and seconded by Commissioner Wagner to approve the low bid for Courthouse plantation shutters from Rose of Sharon Shutters @ \$98,318

with 25% down and paying each floor in full as all shutters on that floor are installed as presented by Commissioner Long. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Berry and seconded by Commissioner Long to approve the Contract Amendment with Tyler Technologies @ \$161,670.82 as presented by Jackie Olson, County Auditor. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Long and seconded by Commissioner Wagner to go out on bid for window well grinder pumps as presented by Commissioner Long. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Ray and seconded by Commissioner Berry to accept the Yearly Financial Reports for year ending August 31, 2022 from the Howard County Juvenile Probation Department and the 118th Judicial District Community Supervision and Corrections Department as presented by Jackie Olson, County Auditor. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Wagner and seconded by Commissioner Berry to accept the County Clerk's Monthly Financial Report for December 2022 as presented by Brent Zitterkopf, County Clerk. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

Brian Klinksiek, County Road Administrator, informed the Court that the truck that hauls the skid steer on jobs has lost 1st gear and was being sent for repairs. Talking to the repairman they are looking at a possible \$9000 transmission. No action needed.

A motion was made by Commissioner Long and seconded by Commissioner Ray to approve the low bid for RFB 2023002 (Sealcoat) from Ronald Wagner & Co. @ \$1,023,848.16 as presented by Brian Klinksiek, County Road Admninstrator. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

Brian Klinksiek, County Road Administrator, presented to the Court Non-Routine Maintenance Projects 2022009 Old Colorado City Road and 2023004 Base Stabilization on CR 46 that the Road & Bridge personnel will be completing. No action needed.
