The Workshop was called to order @ 1:36 PM.

Randy Johnson, County Judge discussed Health Procedures for COVID. It was discussed that there seems to be an increase in positive cases in Howard County.

A motion was made by Commissioner Long and seconded by Commissioner Berry to nominate Scott Emerson for the Howard Central Appraisal District Board of Directors. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Long and seconded by Commissioner Berry to give Lindsay Wilkerson, County Attorney, permission to pursue acquisition of property at 301 Spring Creek Road along with title insurance. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.
