BE IT REMEMBERED that on the 8th day of January, A.D. 2024 the Commissioner Court of Howard County met in Regular Session at 10:00 AM with RANDY JOHNSON, County Judge as the Presiding Officer. The following members were present: EDDILISA RAY, Commissioner Precinct No. 1, CASH BERRY, Commissioner Precinct No. 2, and DOUG WAGNER, Commissioner Precinct No. 4. JIMMIE LONG, Commissioner Precinct No. 3 was absent.

The meeting was called to order @ 10:04 AM.

The Court discussed implementation of Senate Bill 22 where the District Attorney, County Attorney and the Sheriff's Office can apply for a grant from the State. Joshua Hamby, District Attorney, is hoping he will be able to hire an additional Prosecutor, In addition, he is hoping to raise the pay for Investigators and Prosecutors. Lindsay Wilkerson, County Attorney, is thinking of possibly hiring a Paralegal for her office as well as a part-time employee to scan old records. Judge Johnson reported that he has applied for the Sheriff's Department to receive the grant, which reportedly can be used for vehicles or anything the Sheriff's Department uses. This was all for information and no action needed at this time.

A motion was made by Commissioner Berry and seconded by Commissioner Ray to accept the December 2023 Monthly Reports for Angela Griffin, JP 1-1; Kandi Campbell, JP 2-1; Casey McPherson, County Extension Agent; the 911 Board Minutes and Financials as presented by Judge Johnson. A motion was made by Commissioner Ray and seconded by Commissioner Wagner to respond to the City of Big Spring that the County is not interested in purchasing the property the City of Big Spring owns that was offered first to the County. A motion was made by Commissioner Ray and seconded by Commissioner Berry to approve the Invoices, excluding flowers on the TIB Credit Card in the amount of \$117.94, as presented by Jackie Olson, County Auditor. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Berry and seconded by Commissioner Ray to approve the Budget Amendments as presented by Jackie Olson, County Auditor. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Ray and seconded by Commissioner Wagner to accept the Auditor's Monthly Report for November 2023 as presented by Jackie Olson, County Auditor. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

Jackie Olson, County Auditor, presented an Information Only item concerning the keeping of a 2020 Chevrolet Tahoe for parts rather than relinquishing it to the insurance company. No action needed.

A motion was made by Commissioner Berry and seconded by Commissioner Wagner giving permission to enter into a Joint Primary Election Services Contract with the County Elections Officer State of Texas, County of Howard as presented by Jodi Duck, Elections Administrator (not filled out or signed at the time of Court). A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

Brian Klinksiek, County Road Administrator, gave the Roadway Update stated the department has been cleaning out ditches. He had nothing else to report at this time.

A motion was made by Commissioner Ray and seconded by Commissioner Berry to approve the low bid from CK Newberry on RFB 2024001 (Sealcoat) in the amount of \$1,419,372.09 as presented by Brian Klinksiek, County Road Administrator. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Berry and seconded by Commissioner Ray to accept the low bid from Herring Services on RFB 2022002 (Inverted Prime) in the amount of \$208,858.72 as presented by Brian Klinksiek, County Road Administrator. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

Brian Klinksiek, County Road Administrator, gave an Intersection Plan for State Highway 350 and the Old Colorado City Highway stated he is working on a policy for this type of intersection. No action needed on this date.

Brian Klinksiek, County Road Administrator, presented a 2023 Calls/Complaints/Concerns report for 2023. No action needed.

A motion was made by Commissioner Ray and seconded by Commissioner Wagner to accept the County Clerk Monthly Report for December 2023 as presented by Brent Zitterkopf, County Clerk. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.
