WISEMAN**, County Judge as the Presiding Officer. The following members were present: **OSCAR GARCIA**, Commissioner Precinct No. 1, **CRAIG BAILEY**, Commissioner Precinct No. 2, and **JOHN H. CLINE**, Commissioner Precinct No. 4. JIMMIE LONG, Commissioner Precinct No. 3 was out.

The meeting was called to order @ 3:31 PM.

A motion was made by Commissioner Bailey and seconded by Commissioner Cline to publicize in the newspaper that the Commissioners Court is taking resumes in order to appoint someone as a 911 Board Member and make a decision in Closed/Executive Session on October 17, 2018. This decision was made after Kathryn Wiseman, County Judge, informed the Court of the need to appoint someone. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Cline and seconded by Commissioner Garcia to approve a Deed in Lieu of Tax Foreclosure and approve Private Sale to the City of Coahoma with the taxing entities retaining any mineral rights, as presented by Kathryn Wiseman, County Judge. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Cline and seconded by Commissioner Garcia to approve the renewal of Resolution Indigent Defense Grant Program as presented by Kathryn Wiseman, County Judge, in the absence of Jackie Olson, County Auditor. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Cline and seconded by Commissioner Garcia to approve the Purchase Requests as presented by Kathryn Wiseman, County Judge, in the absence of Jackie Olson, County Auditor. There were no Budget Amendments presented on this date.

A motion was made by Commissioner Garcia and seconded by Commissioner Bailey to approve the Payroll as presented by Sharon Adams, County Treasurer. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Cline and seconded by Commissioner Bailey to approve Personnel Considerations as presented by Sharon Adams, County Treasurer. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Cline and seconded by Commissioner Garcia to approve the Treasurer's Monthly Payroll report for September 2018 as presented by Sharon Adams, County Treasurer. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

Sharon Adams, County Treasurer, reported that the Treasurer's Monthly Report will be presented at the next meeting, October 17, 2018.

A motion was made by Commissioner Bailey and seconded by Commissioner Cline to table the Pipeline Right of Way on the Old Airport Property, as presented by Brian Klinksiek, County Road Administrator, pending consultation with the Joshua Hamby, County Attorney. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

The Monthly Right of Way Use Report was presented by Brian Klinksiek, County Road Administrator. No action needed.

A motion was made by Commissioner Bailey and seconded by Commissioner Cline to approve the new Jury selection plan as presented by Colleen Barton, District Clerk. The jury lists will now be pulled by the District Clerk rather than the Elections Administrator. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Cline and seconded by Commissioner Garcia approve to approve funds for travel for staff training out of the Records Management Funds for the District Clerk as requested by Colleen Barton, District Clerk. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

Kathryn Wiseman, County Judge, discussed items that will be coming up on the October 17, 2018 agenda for the Commissioners Court.

Kathryn Wiseman, County Judge, announced that Bennie Green, Justice of the Peace, will be retiring as of December 31, 2018 and that the Commissioners Court will have to appoint someone to fill the last two years of his unexpired term. No action needed on this date.
