BE IT REMEMBERED that on the 19th day of September, A.D. 2018 the Commissioner Court of Howard County met in Regular session at 3:30 PM with **KATHYRN G. WISEMAN**, County Judge as the Presiding Officer. The following members were present: **OSCAR GARCIA**, Commissioner Precinct No. 1, and **JOHN H. CLINE**, Commissioner Precinct No. 4. **JIMMIE LONG**, Commissioner Precinct No. 3 arrived at 3:43 PM.

Court was called to order @ 3:32 PM.

Mitchell Hooper, Volunteer Fire Department Chief, recommended that the burn ban be allowed to expire due to recent rains and more rain being predicted. This would allow citizens to burn off brush, etc. before the Winter weather arrives. Commissioners were in agreement and the burn ban will expire on this date.

A motion was made by Commissioner Garcia and seconded by Commissioner Cline approved the Website Domain Name Contract terms and conditions as presented by Reagan Rainey, Information and Technology Director. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Cline and seconded by Commissioner Garcia to approve the amendments made to the 2019 Vine Service Agreement. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

Nick Benjamin, accompanied by Tye Shelton, with NRG gave a presentation about the proposed Elbow Creek Windfarm Repowering Project. He discussed how the \$88 million project would be beneficial to the taxing entities that would be involved. The project consists of repowering 53 turbines.

A motion was made by Commissioner Long and seconded by Commissioner Garcia to set the Howard County 2018-2019 tax rate at \$0.328024. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Cline and seconded by Commissioner Garcia to approve joining P3 Public Power Pool as presented by David Quin, Program Manager for P3. This will allow P3 to negotiate for better electricity rates for Howard County with a bulk rate advantage. The total cost for the County is an estimated \$130,593, as well as a one-time \$730 fee to join the group. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Long and seconded by Commissioner Cline to approve changes to the following policies: Payment of Claims; Capital Assets; Rainy Day Fund; Purchasing Procedures; Travel Policy; and Jury Pay as presented by Jackie Olson, County Auditor. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Cline and seconded by Commissioner Long to approve the purchase of additional Umbrella Insurance of \$1,000,000 at a cost of \$6817 as presented by Jackie Olson, County Auditor. This will cover over the auto liability, general liability, the public officials liability and law enforcement liability. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Long and seconded by Commissioner Garcia to approve Invoices as presented by Jackie Olson, County Auditor. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.
