BE IT REMEMBERED that on the 26th day of October, A.D. 2015 the Commissioner Court of Howard County met in regular session at 4:00 PM with KATHYRN G. WISEMAN, County Judge as the Presiding Officer. The following members were present: OSCAR GARCIA, Commissioner Precinct No. 1, CRAIG BAILEY, Commissioner Precinct No. 2, JIMMIE LONG, and Commissioner Precinct No. 3. JOHN H. CLINE, Commissioner Precinct No. 4 couldn't make 4:00 but was there for the 5:30 meeting.

Court held a brief budget meeting at 4:00 PM to review the ending year financial balances. No action was taken.

Court recessed at 4:10 until 5:30 for the regular meeting.

All Commissioners were present at this meeting.

Judge Wiseman called for any registered citizen to come forward. Sammy Buchanan was concerned about the new business not making driveways adequate to make the turns on to our County Roads and it is breaking down the edge of the roadways. He also thinks we might need to consider making Moss Lake Road and Midway Roads one way since they are so narrow.

A motion was made by Commissioner Cline and seconded by Commissioner Garcia to approve the 2016 Holidays as presented to Kathryn Wiseman, County Judge. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

Judge Wiseman has met with a gentleman on the application for FVA 2016-2017 Veterans Treatment Court Grant. She needs direction as she has no training in Grant writing. Commissioner Long said since County Attorney and District Attorney sat in on the meeting let them advise as to whether to move forward or not. No action taken.

A motion was made by Commissioner Cline and seconded by Commissioner Bailey to approve the request for the next Unconventional Warfare-Special Ops exercise to be March 10-June 5, 2016. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Long and seconded by Commissioner Bailey to approve the following 10 Right of Ways as presented by Brian Klinksiek, County Engineer:. 1 to Plains Marketing LP on Howard Field Rd; 2 to OXY USA Inc. both on Nichols Rd,; 1 to Three Global on Moore School Rd and 6 to Medallion Pipeline Company LLC on CR 28A,CR 25,WCR 18, Moore School Rd, NCR 23A,and CR 21. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Cline and seconded by Commissioner Long to approve the abandonment of CR 43 north of CR 46 to the land owner in Precinct 4. Court received a request from the landowner. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Long and seconded by Commissioner Cline to table the issue of updating the driveway specs for new business's until Brian can modify the plan that was presented. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Bailey and seconded by Commissioner Garcia to approve the Department Head recommendations as presented by Teresa Thomas, County Treasurer. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Long and seconded by Commissioner Garcia to approve the Bills except the one to Tyler Technologies as presented by Jackie Olson, County Auditor. Commissioner Bailey is to meet with them on Wednesday about it. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Long and seconded by Commissioner Cline to approve the purchase request for the Sheriff to Miller Uniform Patrol for 3 vests @ \$850 each to be paid out the Vest donation fund and the Budget Amendments as presented by Jackie Olson, County Auditor. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Garcia and seconded by Commissioner Long to award the bid for paving and patching materials to Vulcan Materials at \$80,037.50 as was the only bid as presented by Brian Klinksiek, County Engineer. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Cline and seconded by Commissioner Bailey to award bid on the road widening contract labor and equipment to Blackjack Energy Services LLC at \$271,369.35 as was low bid as presented by Brian Klinksiek, County Engineer. This is part of the Road Grant. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

Judge Wiseman read a Thank You card from the Fair Association and an invitation to the 2016 Howard County Junior Livestock Show and Ag Appreciation Luncheon and Awards on January 13, 2016.

Judge Wiseman ask the Commissioners for their closing statements. Commissioner Garcia had no comments. Commissioner Bailey wanted to thank everyone for attending. He once again wanted to remind everyone that we needed to begin working on our representatives to begin recovering the unfunded mandates that are the majority of our budget and start working on next year's budget. Commissioner Long wanted to report to everyone that the financial report that was presented in the Budget workshop earlier reflected that the County is great shape. It is recommended that we have 6 months of operating expenses and we do. Commissioner Cline had no comments. Judge Wiseman wanted to apologize to Court that we are going to have a Special Meeting, Thursday October 29, 2015 at 1:00 PM because she failed to get the appointment of a board member for the Tax Appraisal Board on the agenda for today.
