BE IT REMEMBERED that on the 22<sup>nd</sup> day of August, A.D. 2016 the Commissioner Court of Howard County met in a budget workshop and regular session at 3:30 PM with KATHYRN G. WISEMAN, County Judge as the Presiding Officer. The following members were present: CRAIG BAILEY, Commissioner Precinct No. 2, JIMMIE LONG, Commissioner Precinct No. 3 and JOHN H. CLINE, Commissioner Precinct No. 4. OSCAR GARCIA, Commissioner Precinct No. 1 was absent.

Court opened at 3:30 in a budget workshop.

Jackie Olson, County Auditor presented the proposed budget based on .449498. She informed the Court of all the new funds that she added LEOSE for DA & Sheriff, Sheriff donation fund, cash bond fund, court cost, Mental Health Officer & School resource officer.

A motion was made by Commissioner Cline and seconded by Commissioner Long to give a raise to one Road & Bridge Employee, Junior Rodriguez of \$.50 per hour and give Brian Klinksiek a raise to \$72,500.00 (\$3500.00 increase) per year. To pay for this we will take away from what is to be donated to the rainy day fund and transfer to the Road & Bridge fund. A vote was taken and the following members of the Court voted "AYES": Commissioner Cline, Commissioner Long & Judge Wiseman. Commissioner Bailey did not vote and Commissioner Garcia was absent. Motion carried.

Court recessed @ 3:55 PM to move upstairs.

Court reconvened into open session at 4:02 PM.

A motion was made by Commissioner Cline and seconded by Commissioner Long to NOT approve the Howard County Appraisal District Budget as presented. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A resolution was passed stating that the Commissioners Court of Howard County, Texas voted unanimously to not approve the 2017 Operating Budget for the Howard County Appraisal District.

A motion was made by Commissioner Bailey and seconded by Commissioner Long to approve the First Amendment to the Tax Abatement Agreement regarding the Gunsight Mountain Wind Energy LLC. The only thing that changed was the megawatts. Original agreement said 120 and it actually came in at 119.93 but they will now at the 120 feature.

Court held a public hearing @ 4:20 on the Proposed 2016/2017 County Budget. No one from the public came forward.

A motion was made by Commissioner Cline and seconded by Commissioner Long to set the salary, expenses/allowances of the Elected Officials, as presented by Jackie Olson, County Auditor. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Long and seconded by Commissioner Cline to approve the proposed Budget as presented by Jackie Olson, County Auditor. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Long and seconded by Commissioner Cline to set the proposed Tax Rate at .449498 for 2016/2017. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Cline and seconded by Commissioner Bailey to approve the bills as presented by Jackie Olson, County Auditor. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Bailey and seconded by Commissioner Cline to approve the following purchase requests as presented by Jackie Olson, County Auditor: Sheriff- 2 vest from Miller Uniform @ \$1900.00; Jail - Freon in the Air conditioning unit at \$1419.02 and Library – 2 Ricoh copiers- 1 color (\$ 67.60 per month) & 1 Black & White (\$64.31 per month). A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Long and seconded by Commissioner Cline to approve the Budget Amendment as presented by Jackie Olson, County Auditor. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Long and seconded by Commissioner Bailey to approve advertising for replacement air conditioning/electrical & disconnect boxes for the annex. They want them bid out individually. Some of the disconnect boxes have just been replaced. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Cline and seconded by Commissioner Bailey to approve the Sheriff & Constable fees for 2017. There were no changes to fees. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Long and seconded by Commissioner Bailey to approve the Physician Agreement Contracts for 2016-2017 Fiscal Year and have permission to accept any future agreement during the fiscal year as presented by Irene Dominguez, Indigent Health Director. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Long and seconded by Commissioner Cline to approve the Department Head recommendation as presented by Teresa Thomas, County Treasurer. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Cline and seconded by Commissioner Long to approve the following 6 Right of Ways as presented by Brian Klinksiek, County Road Administrator: 5 to Diamondback Energy on 3 on WCR 50 & 2 on CR 42 and 1 to Outrigger Midland Operating LLC on WCR 52. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

Brian Klinksiek, County Road Administrator had discussion on the roadway "Clear Zone". He wants to start by sending letter to persons who set the Dumpsters and get them to set them outside the 10' distance on all local roads. Court agreed to try the voluntary compliance first. No formal action taken on this date.

Judge Wiseman reported that she had received a County Trapper report.

Court adjourned at 5:00 PM.
