BE IT REMEMBERED that on the 11th day of July, A.D. 2016 the Commissioner Court of Howard County met in a special budget workshop and regular session at 3:00 PM with KATHYRN G. WISEMAN, County Judge as the Presiding Officer. The following members were present: OSCAR GARCIA, Commissioner Precinct No. 1, JIMMIE LONG, Commissioner Precinct No. 3 and JOHN H. CLINE, Commissioner Precinct No. 4. CRAIG BAILEY, Commissioner Precinct No. 2 was absent.

A Budget workshop was held on this date.

Court met with Johnny Schafer from the Library on their budget. Library has now turned over the checkbook to the Auditor. Court agreed for new library copy rate to be \$.25 for Black and White and \$.50 on color copies, when they get the lease machines.

Jackie Olson, Auditor reported that some exempt employees' will have to start punching a time clock by law next year due to the new laws. Some others will have to be raised in order to stay exempt.

Court discussed sick leave policy and longevity

Jackie Olson, Auditor presented the Insurance on Building and contents value.

Court recessed at 5:00 PM to move upstairs in regular session.

Court reconvened at 5:34 PM in the regular meeting.

A motion was made by Commissioner Cline and seconded by Commissioner Garcia to approve the 911 budget for 2016/2017 as presented by Tommy Sullivan, Volunteer Fire Chief. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

No action taken in Budget workshop.

A motion was made by Commissioner Cline and seconded by Commissioner Long to NOT approve the Appraisal District's Proposed Budget and ask for no raises to be given and ask that they cut their budget 10%. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Garcia and seconded by Commissioner Long to table the Agenda item regarding mineral rights in Howard County. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

Brian Klinksiek, County Road Administrator introduced the new TXDOT Area Manager, Matt Evans.

A motion was made by Commissioner Long and seconded by Commissioner Garcia to approve the following 2 Right of Ways as presented by Brian Klinksiek, County Road

Administrator: 1 to Three Global LLC on WCR 25 and 1 to Crown Quest on Longshore Rd. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Long and seconded by Commissioner Cline approve changing the name of Airport Rd to Frazier Rd in precinct 3 pending the signature of Mr. Frazier. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

Brian Klinksiek, County Road Administrator gave an update on the changes to Precinct 1 Roads due to the 87 Reliever Route. Webb Lane will become 2 separate pieces and County Rd 21 will be frontage roads and an interchange.

Brian Klinksiek, County Road Administrator reported that work has completed on Grant Bill #10 and sending in invoice for \$262,074.00.

A motion was made by Commissioner Long and seconded by Commissioner Garcia to approve the bills as presented by Jackie Olson, County Auditor. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.
