BE IT REMEMBERED that on the 13rd day of February, A.D. 2017 the Commissioner Court of Howard County met in special session at 2:00 PM and then in regular session at 3:30 with KATHYRN G. WISEMAN, County Judge as the Presiding Officer. Court reconvened into Open Session at 2:39 PM.

A vote was taken and the following members of the Court voted "AYES": Commissioner Garcia, Commissioner Long and Commissioner Cline. Commissioner Bailey voted "NO". Motion carried.

A motion was made by Commissioner Cline and seconded by Commissioner Long to approve the bills as presented by Jackie Olson, County Auditor. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Long and seconded by Commissioner Cline to approve the purchase requests as presented by Jackie Olson, County Auditor for the Tax Assessor-Collector to remove old tile and replace with new at \$4200.00 top DR Construction.
