BE IT REMEMBERED that on the 12th day of November, A.D. 2021 the Commissioner Court of Howard County met in Public Hearing - Special session at 9:00 AM with **KATHRYN G. WISEMAN**, County Judge as the Presiding Officer. The following members were present: **EDDILISA RAY**, Commissioner Precinct No. 1, **JIMMIE LONG**, Commissioner Precinct No. 3 and **JOHN H. CLINE**, Commissioner Precinct No. 4. **CRAIG BAILEY**, Commissioner Precinct No. 2 was absent.

The meeting was called to order @ 9:08 AM.

The meeting was a Public meeting with only one person from the public attending. Judge Wiseman asked if there were any questions or comments from the Public. There was no response.

Judge Wiseman reported the maximum allowable deviation is 10% and Howard County was currently @ 14.47%. We the new re-districting plan the deviation would be @ 1.33%, far below the allowed amount. Judge Wiseman also stated that if anyone would like to have one of the new maps of the new district lines, they can request on from the Howard County Judge's Office.

A motion was made by Commissioner Long and seconded by Commissioner Ray to sign the Order for Redistricting of Political Boundaries. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.


Commissioner Long also pointed out that changes were made in every Precinct with the exception of Precinct 3.
