The meeting was turned over to Tiffany Sayles, Tax-Assessor Collector who presented the 2022 Governing Body Summary #1A\* Benchmark 2022 Tax Rates Howard County. The No-New Revenue Rate is \$0.220452 and the Voter Approval Rate (VAR) is \$0.238916. Ms. Sayles then signed and certified the rates. No action needed at this time.

The Court took preliminary action to hire Burns Architecture, LLC to begin the process of jail expansion.

A motion was made by Commissioner Bailey and seconded by Commissioner Judge Wiseman to adjourn @ 1:45 PM. A vote was taken and the members of the Court voted 3 "AYES" and 1 "NAY". Motion carried.
