

NOTICE OF MEETING TO VOTE ON TAX RATE

A tax rate of \$0.569723 per \$100 valuation has been proposed by the governing body of Irion County.

PROPOSED TAX RATE	\$0.569723 per \$100
NO-NEW-REVENUE TAX RATE	\$0.623121 per \$100
VOTER-APPROVAL TAX RATE	\$0.728781 per \$100

The no-new-revenue tax rate is the tax rate for the 2025 tax year that will raise the same amount of property tax revenue for Irion County from the same properties in both the 2024 tax year and the 2025 tax year.

The voter-approval rate is the highest tax rate that Irion County may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is not greater than the no-new-revenue tax rate. This means that Irion County is not proposing to increase property taxes for the 2025 tax year.

A PUBLIC MEETING TO VOTE ON THE PROPOSED TAX RATE WILL BE HELD ON August 26, 2025 AT 9:00 a.m AT Irion County Courthouse, 209 N Park View, Mertzon, TX 76941.

The proposed tax rate is also not greater than the voter-approval tax rate. As a result, Irion County is not required to hold an election to seek voter approval of the rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the Irion County Commissioner's Court of Irion County at their offices or by attending the public meeting mentioned above.

No-New-Revenue Maintenance and Operations Rate Adjustments

State Criminal Justice Mandate

The Irion County Auditor certifies that Irion County has spent \$7,540 in the previous 12 months for the maintenance and operations cost of keeping inmates sentenced to the Texas Department of Criminal Justice. Irion County Sheriff has provided Irion County information on these costs, minus the state revenues received for reimbursement of such costs. This increased the no-new-revenue maintenance and operations rate by \$0.000467/\$100.
